MotionTrade is an easy-to-use online stock and mutual fund trading application that provides stable, fast, and secure digital experience. MotionTrade can be used on any device, both Android and iOS-based smartphones and smartwatches, tablets, to Windows or Mac OS based computers. MotionTrade is also capable of executing **voice commands**, a new feature unavailable in any other online trading platforms. Users can use the voice command feature to open various menus, input buy/sell transactions, read news, check stock prices, and access other activities in the application. Account opening can also be done entirely online through MotionTrade.

Transformasi aplikasi online trading kebanggaan MNC Sekuritas berawal sejak tahun 2016 saat aplikasi MNC Trade New pertama kali diluncurkan. Di tahun 2017, aplikasi online trading saham berbasis syariah yaitu MNC Trade Syariah melengkapi sistem online trading konvensional. Seiring berjalananya waktu, kedua versi tersebut terintegrasi dalam satu aplikasi dengan fitur yang semakin lengkap bagi investor pemula maupun berpengalaman.

Agen Penjual Efek Reksa Dana (APERD)

Direktur Utama MNC Sekuritas, Susy Meilina menambahkan, MNC Sekuritas juga memegang lisensi **APERD**, sehingga transaksi saham dan reksa dana juga dapat dilakukan secara praktis melalui MotionTrade. MotionTrade dikembangkan sebagai supermarket reksa dana dengan berbagai pilihan produk dari 14 Manajer Investasi (MI) terbaik. Targetnya, MotionTrade akan menggabungkan produk dari 50 MI yang mewakili 70% total AUM di Indonesia. Dana di Rekening Dana Nasabah dapat digunakan untuk pembelian reksa dana maupun saham. Sedangkan portofolio reksa dana juga dapat dijadikan sebagai jaminan untuk transaksi saham margin.

The transformation of the online trading application, as the pride product of MNC Sekuritas, began when the MNC Trade New application was first launched in 2016. In 2017, the sharia-based online stock trading application, namely MNC Trade Syariah, complemented the conventional-based online trading system. Over time, the two versions were integrated into one application with more complete features for both novice and experienced investors.

Mutual Fund Selling Agent (APERD)

President Director of MNC Sekuritas, Susy Meilina added that MNC Sekuritas also holds **APERD** license, so that mutual fund transactions can also be done seamlessly through MotionTrade. MotionTrade is developed as a mutual fund supermarket with a wide selection of products from the 14 best and well-known Investment Managers (IM). MotionTrade targets to combine products from 50 IMs, which represent 70% of the total AUM in Indonesia. Deposits in the Customer's Fund Account can be utilized to purchase both mutual funds and shares. Meanwhile, the mutual fund portfolio can also be used as collateral for margin stock transactions.
