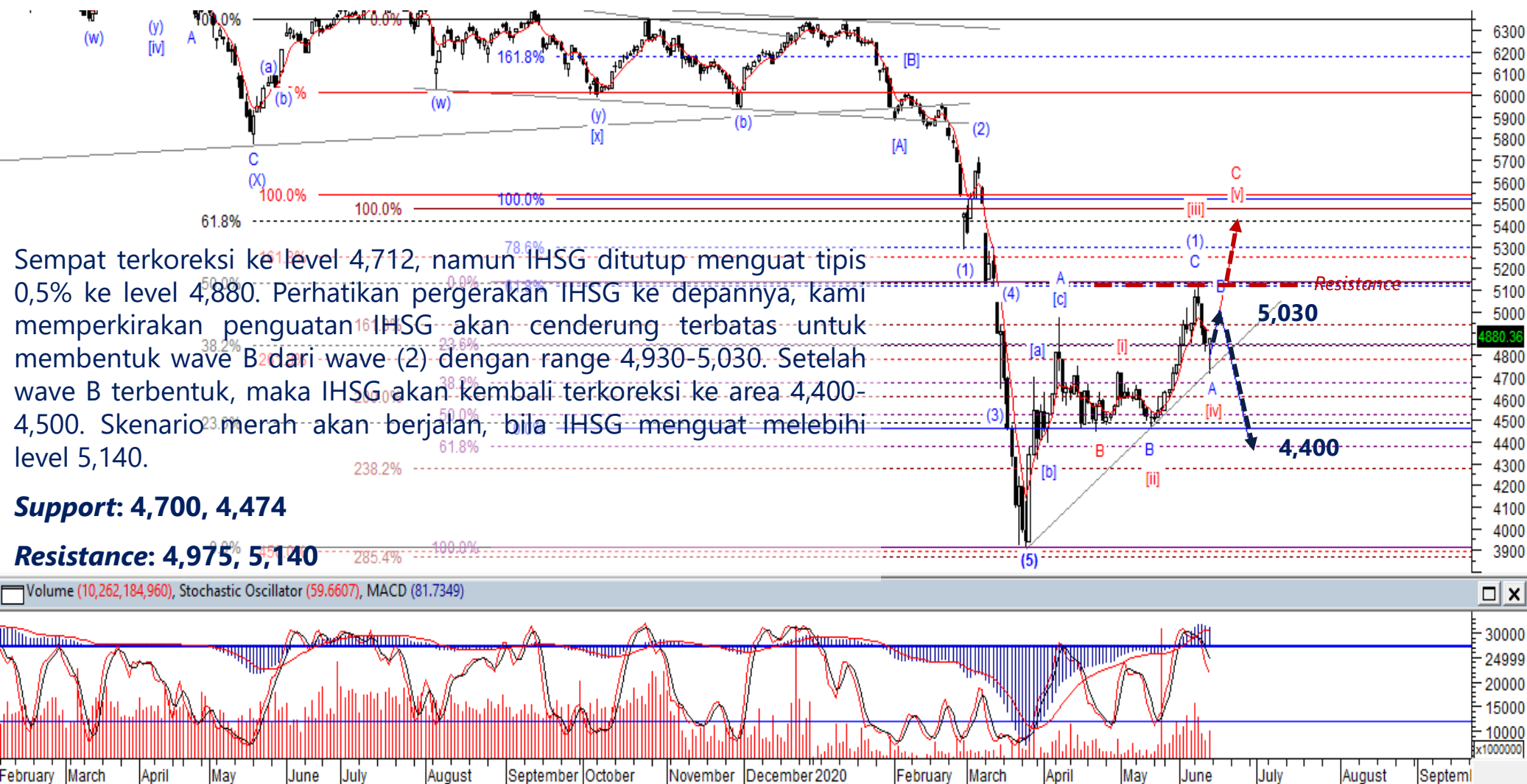
Jakarta Composite Index (JCI) short term (1-2 days) bullish

JCI – Short Term Rebound



Sempat terkoreksi ke level 4,712, namun IHSG ditutup menguat tipis 0,5% ke level 4,880. Perhatikan pergerakan IHSG ke depannya, kami memperkirakan penguatan IHSG akan cenderung terbatas untuk membentuk wave B dari wave (2) dengan range 4,930-5,030. Setelah wave B terbentuk, maka IHSG akan kembali terkoreksi ke area 4,400-4,500. Skenario merah akan berjalan, bila IHSG menguat melebihi level 5,140.

HMSP – Buy on Weakness



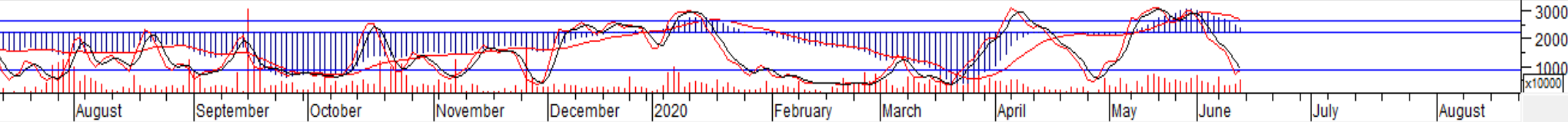
HMSP pada penutupan pekan lalu (12/6) menguat 3,3% ke 1,740. Kami memperkirakan posisi HMSP saat ini sedang berada di awal wave [b] dari wave B. Hal ini berarti HMSP akan menguat dalam jangka pendek terlebih dahulu, sebelum terkoreksi kembali membenetuk wave [c].

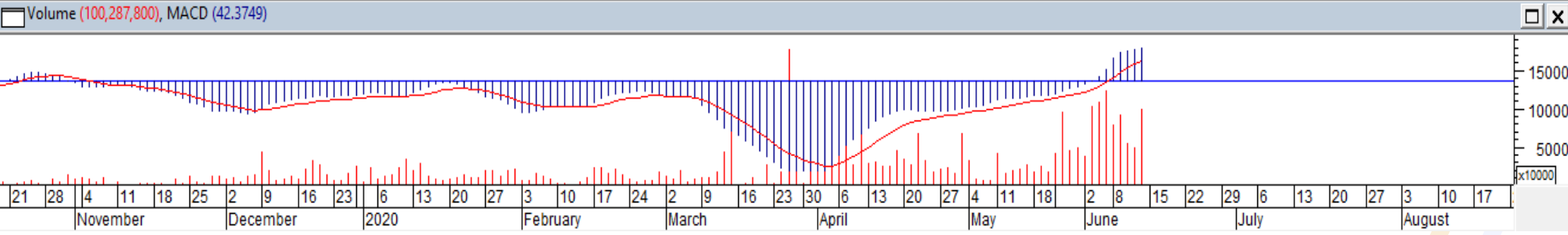


SMRA – Buy on Weakness

Stoploss: below 515

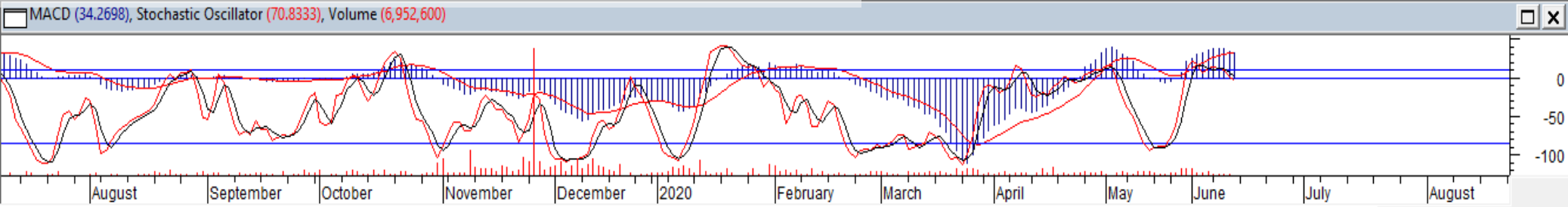


ACES – Buy on Breakout
